## THE ENERGY POVERTY DASHBOARD

### 1.1 Introduction

The Energy Poverty Dashboard is an integral part of the ENPOR project (Energy Poverty in the Private Rented Sector), which seeks to provide an in-depth examination of energy poverty policies for the Private Rented Sector (PRS) across the EU, while supporting the adaption and implementation of policies tailored to the specific needs of the sector. The project also monitors various dimensions of energy poverty in the PRS, while providing a structured knowledge exchange platform.

The Energy Poverty Dashboard (EPD) aims to respond to the lack of Europe-wide data on the PRS, as well as the need for spatial and temporal disaggregation of relevant information, and the mapping of initiatives and interventions. It also establishes a platform for sharing knowledge and practice.

The Dashboard's data is twofold:

- The first element is indicator data, such as the number of people unable to keep home warm, arrears on utility bills, presence of rot or damp and so on, collated by country and regions over 15 years, which has also been disaggregated so that it can be viewed for the population as a whole, or for tenants only.
- The second part is a mapped resource of policies and measures that in some way address energy poverty or work to improve energy efficiency in the PRS across Europe. This aspect is open resource that anyone can submit policies to, which are reviewed and updated by the EPD team.

More information on the Dashboard, its functions and data will be explored in D2.5, the EPD User Guide.
