## 1. INTRODUCTION

To disseminate the project's research outcomes and engage in constructive dialogue with key stakeholders at the EU level, ENPOR meticulously organised and participated in a diverse array of events over the project's timeline. This report systematically summarises the multifaceted outcomes of these events, categorising them into distinct formats such as conferences and workshops.

Within the context of project dissemination and stakeholder engagement, ENPOR assumed a dual role, acting as the organiser of several policy events and actively participating as speakers. As outlined in the Grant Agreement, ENPOR committed to a minimum presence at six events, dedicated to the dissemination of project material and participation as speakers or project presenters. A closer examination of the table above underscores that ENPOR not only fulfilled but substantially exceeded this requirement, engaging in 172 events across various countries, conducted through both online and in-person platforms.

The tabulated overview delineates the nature of events orchestrated by ENPOR, distinguishing between conferences and workshops. Subsequently, the table provides a breakdown of conferences, workshops, and other significant events where ENPOR played an active role. To provide a nuanced understanding, specific attention will be given to select key events in the following sections. This approach aims to delve deeper into the substantive aspects of selected event, elucidating the inherent value they held for advancing ENPOR's mission and objectives.

## 2. ENPOR ORGANISED EVENTS

### 2.1 Policy events/Conferences

#### National Meetings on energy poverty, 24 June 2021, 19 June 2022 & 14 November 2022

The “Inspiration session Tackling energy poverty through energy coaching” took place on 24 June 2021. In this online inspiration session, 40 participants talked about their experiences after an interesting introduction by an energy coach. The event also discussed the do’s and don’ts for an effective approach to energy poverty through energy coaching programs.

The second session titled “Energy coaches training in advising effectively on concerns about energy costs” focused on the question of how to advise people who are struggling to pay their energy bills due to rising energy prices. Especially residents in a poorly insulated house, with a high energy bill and/or a lower income are at increased risk of energy poverty. As part of the ENPOR project, the Centre of Expertise Smart Sustainable Cities and the Co-design research group of HU University of Applied Sciences Utrecht have developed a two-afternoon training course to help the coaches.

In the “Tackling energy poverty!?” digital meeting, discussed how to combat energy poverty in the Netherlands considering rising energy prices and poorly insulated homes. The meeting focused on a range of approaches and research in the field of energy poverty. As this phenomenon occurs among all kinds of residents. During this meeting, the participants looked at different approaches in the private rental sector, the social rental sector and owner-occupied homes.

#### UIPI Renovation Tour "Greek owners on Board", Athens (Greece), 11 March 2022

The UIPI Renovation Tour event series’ aim is to raise citizens awareness (and in particular individual building owners) about European, national and local climate and energy objectives for the building stock by facilitating local policy debates and exchanges between property owners, stakeholders and policymakers. It also aims to address specific challenges and propose concrete solutions and tools to facilitate renovation. The UIPI Athens Renovation Tour (11 March 2022) was the occasion to focus on Greek policies and actions to



tackle energy poverty policy and the split incentive dilemma in the private rented sector.

**UIPI Renovation Tour “Emilia Romagna Owners and Professionals on Board”, Bologna (Italy), 24-25 May 2023**



A second UIPI Renovation Tour in Bologna was featuring ENPOR Project. The event brought together around 80 participants (local property owners from the region of Emilia Romagna). It was organised in association with ENEA, the Italian Property Owners association’s Confedilizia (part of ENPOR React Group), Order of Engineers of Bologna, and University of Bologna (UNIBO). ENPOR has been taking part in the practical assistance session and run by ENEA.

Experts from the EU-funded ENPOR and ENSMOV projects also presented practical recommendations on how several EU countries can overcome problems arising from split incentives.

**ENPOR EUSEW 2023 Policy Session on “Tackling energy poverty through national building renovation plans”, Brussels (Belgium), 21 June 2023**

The European Sustainable Energy Week Policy Conference, the largest conference in Europe dedicated to renewables and efficient energy use, held its 17th edition in Brussels (and hybrid) revolved around the theme of 'Accelerating the clean energy transition - towards lower bills and greater skills'. The ENPOR policy session, organised by UIPI, was part of the thematic bloc *Affordability and inclusion*.





It took place on 21 June 2023 (16:30 to 18:00 CET), at the European Commission's Charlemagne building in Brussels and brought together 122 online participants and 66 presential ones including European, national and local decision-makers, energy efficiency stakeholders and researchers from all other Europe. It focused on presenting various supporting tools for designing national renovation strategies and related requirements to address energy poverty. It included a first presentation of the [ENPOR Energy Poverty Dashboard](#) and existing national best practices to assess, measures and tackle energy poverty, including in the Private Rented Sector. The event was also the occasion to exchange with DG ENER Building Unit on the matter. The purpose was to prepare the future implementation of the Energy Performance of Buildings Directive and in particular the preparation of the National Renovation Strategies that will soon need to be drafted by Member States.

### **ENPOR National Event: Innovative Solutions to Fight Energy Poverty in Austria - The Potential Role of Energy Communities, Vienna (Austria), 27 September 2023**

The “Innovative Solutions to Fight Energy Poverty in Austria” conference, held on September 27, 2023, at the Architecture Centre Vienna, addressed the challenges posed by recent crises and explored measures to promote renewable energy and combat energy poverty. The conference highlighted the role of energy communities in these efforts.

The event began with discussions on the impact of crises, emphasizing the vulnerability of certain population groups. Measures to reach low-income households and the importance of clean and affordable energy were discussed. The focus was on both short-term solutions and necessary structural changes, requiring comprehensive data on energy poverty.

Efforts to provide energy knowledge to households were presented, including initiatives like the ENPOR project and the "Social energy counselling" program for social workers. Practical examples of energy counselling, emphasizing understanding and managing energy consumption, were also shared.



The conference delved into the potential of energy communities to support households affected by energy poverty. Motivations for establishing such communities and innovative projects were discussed. Challenges in their implementation, such as tariff levels and energy purchase caps, were acknowledged.



Representatives from the Climate and Energy Fund and the Austrian Red Cross emphasized the need for both structural changes and tailored solutions to address energy poverty. The complexity of the issue, involving multiple stakeholders, was underscored, along with the call for improved data for more effective solutions.

The event concluded with a consensus on the innovative potential of energy communities, particularly solidarity energy communities, as a practical tool for ensuring a renewable energy supply and supporting citizens affected by poverty. The visual recording of the event highlighted key messages, emphasizing the urgency of implementing these innovative solutions.

**ENPOR Final Event: “Combating Energy Poverty in Europe” Conference Addresses Urgent Concerns and Proposes Solutions, Brussels (Belgium), 16 November 2023**

The conference was co-organised by the International Union of Property Owners (UIPI), the ENPOR project, and the European Federation of National Organisations Working with the Homeless (FEANTSA) and focused on evaluating and enhancing measures to address energy poverty within the European private rented sector.



The sessions delved into various tools, breakthrough initiatives, and good practices to combat energy poverty, with a





particular focus on the private rented sector. A noteworthy exploration included the Social Rental Agency model, a promising solution connecting unoccupied apartments with disadvantaged households.

The conference featured a panel of EU policymakers, experts and practitioners, including representatives from EU institutions, flagships European projects to combat energy poverty (ENPOR, EnergyMeasures and ComAct), and the ENPOR pilot countries – Germany, the Netherlands, Italy, Croatia, Austria and Greece. These experts shared insights and experiences to address the complex challenges associated with energy poverty in the private rented sector. Discussions centered around the ENPOR project's key recommendations, emphasizing the need for targeted information standardised definitions, integrated strategies for building renovations as well as specific tools, training for key professions such as social workers, engagement of local stakeholders.

## 2.2 Workshops

### **Workshop at the Climate Alliance International Conference 2021 - Energy Poverty: Why is it important and how can municipalities fight it? 09 September 2021**

Climate Alliance led the initiative to co-organise the Workshop on Energy Poverty: Why is it important and how can municipalities fight it? on 9 of September 2021, 14:00-15:30 CET (online). The Workshop was announced under the umbrella of The Covenant of Mayors Europe and was supported by the EU Energy Poverty Advisory Hub as part of the Climate Alliance International Conference. Out of the 102 registered participants, 62 participated where 40 were local, regional, and national policy makers and public administration representatives, while the rest NGOs, researchers and others. The event was announced via Climate Alliance as well as via Covenant of Mayors and ENPOR channels. In the Lightning Talks Marlene Potthoff (Caritas Germany) and Florin Vondung (WI) highlighted lessons and challenges for reducing energy consumption of vulnerable groups in municipalities showcasing ENPOR's work with the German Stromsparcheck measure. An announcement and invitation was mailed via the second special ENPOR News issue "Registration open: Energy Poverty Workshop" on 5.8.2021 to 180 recipients and is available online.

### **Energy poverty and the future costs under the EED, 24 December 2022**

The event organised by IEECP allowed gathering members of the European Commission, European Parliament and National Ministries to discuss key results from projects and initiatives on the topic of energy poverty and the role of policies to alleviate it. Speakers discussed the role of the Fit-for-55 package, Art. 7 EED policies as well as EU funds and their impacts on low-income groups. They also exchanged how the multiple indicators that capture the dimensions of energy poverty are a result of these policies. The event discussed the following:

- The role of the Fit-for-55 policies (new energy efficiency targets, phasing out of new fossil fuel boilers, Minimum Energy Performance Standards, and potential interactions with the proposed ETS for buildings),
- The impacts on low-income groups and the importance of Art7 EED policies to alleviate the burden, as well as the importance of multiple indicators for capturing the dimensions of energy poverty as a result of these policies.

**EPAH National Event in cooperation with ENPOR: Socially Just Climate Protection: Approaches for an Inclusive Energy Transition, 25 September 2023**

The German government's goal is socially just climate protection that promotes social cohesion and guarantees social balance. After all, whether it's electricity blackouts due to high energy prices, the heating exchange or the 49-euro ticket - climate protection measures are closely related to issues of social justice and should result in a targeted distribution of financial resources.



The energy transition affects a wide range of areas, from housing and mobility to social, economic and financial policy. How can we ensure that it is designed to be socially just? How can we cushion social hardships in connection with the Building Energy Act in order to preserve affordable housing? And how can energy cooperatives, for example, remedy the situation? The event, organised by Climate Alliance through the Energy Poverty Advisory Hub in collaboration with the Horizon 2020 project ENPOR, offered the opportunity to discuss these questions and develop possible solutions for the participant's regions. It provided inspiration to develop differentiated strategies for each regional project so that no one is left behind in energy poverty due to the energy transition.

**ENPOR Validation Webinar (WP5) and Policy Forum (WP4), 09 October 2023**

The ENPOR Policy Forum set the scene with the key results for policy recommendations to national and local policy makers: "What Research Tells Us: Alleviating Energy Poverty in the Private Rented Sector". It included a feedback session and presentation / validation of the project outcomes: "Co-creating policy measures: challenges and opportunities". The day continued with the ENPOR Validation workshop. ENPOR worked on several policy measures to improve via co-creation with target groups and stakeholders in the last years, taking into account the special perspective of energy poor households in the private rented sector. As our project comes to an end, we were ready to hear opinions on our findings at this webinar. This event allowed us to get input in terms of replicability and meaningful change.



The Advisory Board was extended for the final event, as the Policy Forum was merged into the Validation Workshop, thus setting up an online validation event with 2 parts of altogether 3,5 hours, where the first part was focusing on the policy recommendation aspects and the second part was focusing on the validation of results with REACT Groups. This way, a smooth validation experience was created for both policy and implementation and validation aspects offering also the opportunity for both the practitioner and policy maker group to interact with each other. As this event was organised for an invited group, being an internal project event, no public materials was uploaded to the website. **Adverse impacts of these policies and the role of the EU funds to alleviate the burden to the low-income groups. Energy Poverty - CoM-EPAH-ENPOR Policy Workshop at Grafting Cities Conference, 19 October 2023**

The Covenant of Mayors Europe joined forces with the ENPOR Project and the EU Energy Poverty Advisory Hub to organise its workshop for local and regional stakeholders entitled: “Workshop on Fighting Energy Poverty: Tackling energy poverty in a strategic way”. The event was part of the Grafting Cities Conference, a joint event of Climate Alliance, Energy Cities, AEEES Modena and the City of Modena on 19 October 2023, 15:00-17:00 CET. The workshop aimed to support local and regional authorities in understanding how to implement successful measures to mitigate energy poverty. It also explored the needs of multilevel governance when tackling energy poverty, identifying, and collaborating with stakeholders, measuring energy poverty, supporting structures for energy vulnerable households, adjusting energy efficient renovation frameworks to encompass an energy poverty perspective and energy communities as support for energy poor households.

## 2.3 Other events

### **ENPOR Lunch Talk: Making Energy Poverty Visible for the Private Rented Sector, 02 November 2021**

This event was the launch of a new online tool to support authorities to improve local, regional and national policy measures targeting citizens in energy poverty in the private rented sector. The Energy Poverty Dashboard (EPD) will increase the visibility of energy poverty in the PRS, particularly compared with levels of energy poverty within the general population. It will increase opportunities for collaboration between stakeholders, as best practices and policies tackling energy poverty in the PRS are mapped. This tool will indicate where they are concentrated and the effects/impacts of the policies on tackling energy poverty in a particular locale. The EPD is dynamic and updatable over time so that newest data can be shown and also an ability for future interventions to be collected and mapped. This ENPOR Lunch Talk was followed by the third Lunch Talk on the 7th of December focusing on how the Fit for 55 Package impacts energy poverty – with invited guest Ms Louise Sunderland (RAP).

### **UN Climate Change Conference (COP 26), Side Event: Engaging citizens in urban climate action for inclusive just transition, 4 November 2021**

As a side event at COP'26: Empowering vulnerable families in their energy-efficiency refurbishment (4 November 2021), ENPOR contributed at a session titled 'Engaging citizens in urban climate action for inclusive just transition programs' (hosted at the Blue Zone, Lomond Auditorium). The event was face to face as well as streamed and recorded. Tine Heyse, president of the board of Climate Alliance of European Cities and Mayor for Environment, Climate, Energy of Ghent was on site at United Nations Framework Convention on Climate Change (UNFCCC)'s COP'26 to appeal at fellow policymakers to introduce concrete measures expanding them to the rental sector. The side event of the Conference was streamed online via the official YouTube channel of the UN Climate Change Conference. ##### "Social Innovation: Next steps in the Energy Transition", TU Delft, 20-23 June 2022

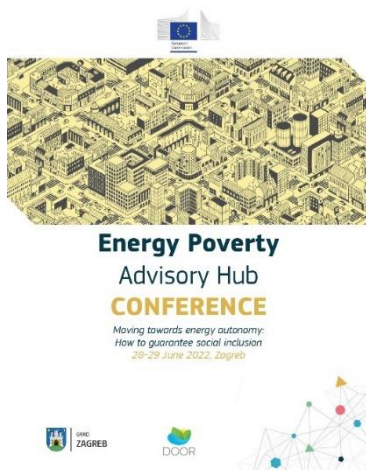
UPRC and UoM participated in the "Social Innovation in the Energy Transition" (SIET) Conference organised by the Technical University of Delft, presenting key findings in the panel "Energy Justice and Energy Democracy", with the contribution "Setting the Scene for Tackling Energy Injustice in the European Private Rented Sector-Findings from the ENPOR project". For the needs of the participation in the conference UPRC prepared, in collaboration with UoM, an abstract and a presentation of the D2.1, D2.2, and D2.3 findings. Moreover, UPRC contributed to the preparations for the UIPI Renovation Tour in Athens (coordination calls, preparation of presentation, etc.) which took place in Athens on the 11th of March, 2022. Finally, UPRC contributed to the preparation of an ENPOR session in the 3rd International Energy Research and Social Conference which will take place at the University of Manchester on 20-23 June 2022.

##### 2nd EPAH Conference, Session 6: The challenges of building renovations as a key solution to energy poverty reduction, Zagreb (Croatia), 29 June 2022

This conference brought together local governments, EU representatives, policymakers, energy agencies, civil society organisations and all stakeholders active in energy poverty. The agenda included a mix of keynote speeches, debates, interactive workshops and field visits that allowed the participants to debate, learn from each other, and share practices as to how the EU, national and local actors can work together to contribute to the rapid energy transition and reduce energy poverty for all including energy-poor and vulnerable consumers.



In session 6, participants unravelled different Member States' experiences for supporting energy efficiency improvements, while fostering the discussion on the challenges, impact and relevance of existing funding schemes to deep energy innovations, the Renovation Wave and energy poverty mitigation.

**EUSEW 2023 ‘Implementing minimum energy performance standards in a socially fair way’, 21 June 2023**

Organised by European Federation of National Organisations Working with the Homeless (FEANTSA) and bringing together representatives from cities, tenants (International Union of Tenants) and property owners (UIPI), this EUSEW 2023 policy session was focusing on how to make the implementation of MEPS a success, notably by tackling the split incentive dilemma. ENPOR was mentioned as a good practice example and outcomes of WP2 were used as a reference during this event.

**ECPR Conference 2023, 12 October 2023**

In view of the energy crisis, supply chain disruptions, as well as rising fossil fuel and electricity prices, combating energy poverty has become a vital issue. In the last year, the number of people experiencing energy vulnerability or poverty throughout Europe has risen and will likely continue to do so. Various reasons can be traced back as to why such an increase in energy poverty numbers has happened, including the last two major disruptions experienced in the past 5 years, namely the COVID-19 pandemic and the Russian-Ukrainian war. To combat this phenomenon, new policy measures need to be introduced by governments. Since energy poverty is a socio-economic issue, touching upon various areas of knowledge, a multidisciplinary approach needs to be taken. For this reason, the following panel considers diverse policies proposed to alleviate energy poverty. These may stem from varying fields of research and backgrounds, so long as the common end-goal is combating energy poverty. This holistic approach avoids the limitation of gathered knowledge to be centered on one specific area of expertise, enabling comparison between approaches as well as lessons learnt from national contexts. By gathering papers and results on niche sectors experiencing energy poverty in different countries, an overview of possible policies proposed to combat energy poverty was obtained.

The PowerPoor Brokerage Event was a unique opportunity to meet companies, research centres and public administrations working on EU Energy Projects and innovative finance mechanisms. Other topics of discussion were how Europe is providing solutions to the current energy challenges, how to bring energy poverty projects into local actions, the importance of boosting citizen participation in the renewable energy development and future opportunities to achieve the energy transition.



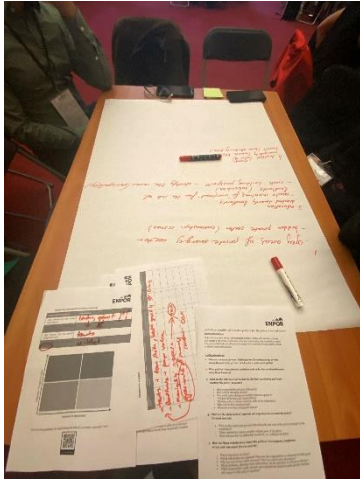

#### International Annual Conference on Energy Poverty, 19 September 2023

ENPOR participated in the International Annual Conference on Energy Poverty taking place on 19-20 September 2023 in Warsaw (Poland). The event has been organised by the Energy Poverty Advisory Hub (EPAH) and the Directorate-General for Energy (DG ENER) of the European Commission in collaboration with the City of Warsaw and with the support of the Committee of the Regions as well as the Polish Network Energie-Cités (PNEC). The main audience consisted of local governments, policymakers, experts, and stakeholders dedicated to addressing energy poverty and fostering sustainable solutions at the local level.

ENPOR co-hosted the session “Collaborative approaches: Partnerships for energy poverty reduction” on 19 September, 14:00 to 15:30 CEST with the aim to explore the benefits of forming partnerships among different stakeholders to effectively address energy poverty through policy recommendations and local actions. DOOR presented the ENPOR developed approach to collaboratively design targeted and practical policies through Regional Action (REACT) groups.



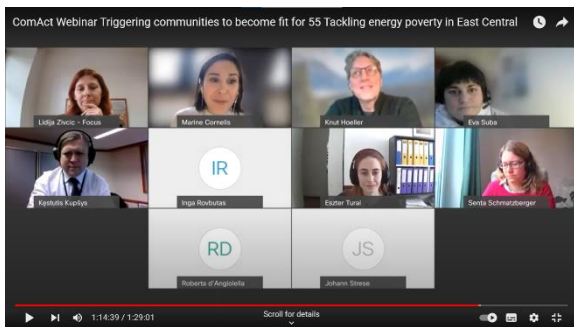


Next to a presentation, a workshop was carried out in which around 6 participants per group created their own Stakeholder Engagement Strategy (SES) for energy poverty in PRS. The participants identified difficulties in identifying households vulnerable to energy poverty in PRS and mapped relevant stakeholders and policies. Subsequently, the detected stakeholders and policies that could target energy poverty in PRS and carried out an analysis of power and interests and lastly focused on community strategies to approach relevant stakeholders to co-design policies targeting energy poverty in PRS.

Overall, thanks to experience-based presentation of ENPOR, the event was successful in underlining the importance to evaluate and implement new policies and programs that contribute to vulnerable groups, to reduce energy poverty in the PRS.

### 3.3 Other events

#### **ComACT Webinar: Triggering Communities To Become Fit-For-55. Tackling Energy Poverty In East-Central Europe, 14 December 2021**



ENPOR participated in the first Webinar of ComACT on 14 December 2021 on energy poverty, specifically on the new EU rules for energy efficiency within the fit-for-55 package. The objectives of this webinar included highlighting the issue of energy poverty in Europe in light of the fit-for-55 package goals, discussing ideas and potential

solutions for the lack of a common definition of energy poverty, and presenting the latest ComAct results related to the energy poverty concept and how they can fit under the Fit for 55 goals. During a panel discussion, Climate Alliance contributed on behalf of ENPOR to the conversation.

#### **How to achieve a socially just EU Renovation Wave? 13 June 2022**

IEECP was happy to host, together with [EURACTIV](#), a hybrid event (in-presence in Brussels and digital), on June 13, from 5pm to 6.30pm to discuss how a socially just EU Renovation Wave can be achieved and how a massive renovation of buildings can be triggered in the coming decade while ensuring that energy poverty is eradicated. IEECP's Vlasis Oikonomou made put forth the idea that if well-designed, the EU Renovation Wave has the potential to cut low-income households' energy costs by a third and increase their disposable income with home renovation and a switch to clean heating. Among others, he suggested that policies to boost home renovation and the uptake of renewable heating could deliver a fairer society and alleviate energy poverty, ensuring that the most vulnerable have access to clean, affordable energy and live in energy-efficient homes.

#### **Training series on Social Energy Advice in Austria (module 1), 4 & 11 October 2022**

Module 1 of the training series on Social Energy Advice was held the first time on October 4 and 11, 2022, and aimed to equip social workers with the knowledge and skills to provide low-threshold energy advice to households. This initiative, organized by AEA as part of the klimaaktiv program under the Federal Ministry for Climate Action, addresses the challenges posed by the energy crisis. The training, supported by ENPOR, focuses on enabling social workers to assist vulnerable households with energy-related issues.

The first module covered essential topics, including an overview of annual energy bills, distinguishing between energy advice and financial advice, and identifying reasons for significant increases in energy consumption. Additionally, the training delved into areas such as heating, hot water, indoor climate, and recommendations for energy-saving behavior. The success of the event lay in its relevance to the daily work of social workers, providing

them with practical knowledge to support clients coping with the current high burden of energy prices. The training emphasized the importance of understanding energy bills, implementing energy-saving measures, and conducting on-site consumption assessments.

The second session of the training series revisited the contents of the first unit of module 1, with a detailed focus on energy bills and their interpretation. The discussion included the possibility of changing suppliers, introducing comparison tools, and addressing relevant causes for high electricity consumption. The training further explored appliances contributing to high electricity consumption and provided recommendations for their efficient use.

The session also covered assistance for households, including contacts with energy suppliers or repair services. Additionally, social workers were informed about a new subsidy program for energy-poor households in Austria, encouraging the exchange of old, inefficient large electrical appliances with new ones at a 100% subsidy rate.

Once again, the success of the event was attributed to its practical relevance for social workers, offering insights and tools to better assist clients facing the challenges of high energy prices. The training series is set to continue regularly, contributing to the ongoing effort to empower social workers with the knowledge needed to address energy-related issues within vulnerable households.

### **Training series on Social Energy Advice in Austria (module 2), 12 & 20 April 2023**

Module 2 of the training series on Social Energy Advice was held the first time on 12 April and 20 April 2023, and focused exclusively on individuals actively counselling households on energy costs and consumption. This training module was also supported by ENPOR in its implementation. Module 2 delved into the details of energy bills, providing participants with comprehensive information on various aspects, including forms of energy billing, reading electricity and heat meters, consumer rights, and related issues.

During the first session on April 12, 2023, the focus was on electricity and natural gas. A notable feature of this session was the participation of experts from the regulatory authority for energy, E-Control, who addressed energy bills and consumer rights. The session covered contractual partners, the composition of energy prices, the structure of electricity and gas bills, meters and meter reading, tariff calculators, switching suppliers, price increases, and customer rights. Existing support services, such as basic supply, electricity cost brake, and instalment payments, were also presented. The participants showed high interest in these topics, recognizing their importance for supporting clients and gaining a better understanding of the energy supply system.

The second session on April 20, 2023, focused on district heating, with experts from the Austrian Chamber of Labour contributing their insights into district heating bills and consumer rights. Topics covered included housing law and heating costs, key terms related to district heating, the legal framework, systematics of district heat billing, billing checks, and typical costs and consumption in households for heating and hot water. Practical billing examples were presented, reflecting the complexity of district heating bills, and discussions addressed common difficulties for households.

The training was deemed highly successful as district heating and billing mechanisms are often complex for consumers. The expert inputs provided during the sessions were crucial for participants to gain in-depth knowledge, enabling them to better support their clients in

navigating the complexities of energy bills and district heating. The training series contributes to enhancing the expertise of advisors and empowering them to address the challenges faced by households in understanding and managing their energy costs. ## 4. CONCLUSION

As can be seen throughout this document, this project entailed an extensive amount of communication which were carried out by all partners to the project. Over the past few years, the ENPOR project has actively addressed energy poverty through a series of conferences and workshops. One notable effort was the International Energy Poverty Action Week, including a dedicated day for Europe, where online conferences engaged participants on February 23, 2022. Similarly, IEPAW'2023, held from April 20 to April 24, 2023, served as a significant engagement event. It also Austria played a focal point in combating energy poverty with the event "Innovative Solutions to Fight Energy Poverty in Austria," a final national ENPOR initiative organized by AEA. This physical conference occurred on September 27, 2023, at the Architecture Centre Vienna. ENPOR's involvement extended to national conferences organised by DOOR featuring physical gatherings in Busevec on May 13, 2022, and twice in Zagreb on June 2, 2023, and August 31 - September 1, 2023. The events also entailed the UIPI Renovation Tour with events in Athens, Bologna, and Liège on March 11, 2022, May 24, 2023, and June 29, 2022, respectively. These events were organised in conjunction with national associations of property owners and other EU-funded projects. ENPOR also actively engaged with EUSEW 2023, contributing to a policy session on "Tackling energy poverty through national building renovation plans" on June 21, 2023. The project maintained a presence in various lunch talks and workshops, covering topics from tailored measures for energy poverty to the challenges of building renovations as a key solution.
