1 INTRODUCTION

This deliverable provides an overview of materials and activities developed from Month 18 to Month 42 (February 2022-November 2023). For previous materials and activities, please refer to Deliverable 6.7.

Following the COVID pandemic, where the ENPOR dissemination and communication took place predominantly through online events, meetings and other engagement activities that were taking place online, while events were started to be organised face-to-face in 2023. Nevertheless, the pandemic transformed the way the project dissemination and stakeholder engagement as well as communication was first envisaged and due to the availability of stakeholders, several events originally envisaged to be organised face-to face, in connection with project meetings, were kept as online events. The digital channels of the ENPOR project have been used extensively and regularly. The format of the “Lunch Talks” was developed to be able to engage stakeholders with ENPOR outcomes but also to ensure continuous exchange to build up policy support for the work done in ENPOR. Once the online Lunch Talks series was finished, and ENPOR moved on to organised capacity building events and webinars, the format of the Lunch Talks was picked up by the Energy Poverty Advisory Hub and continued to make impact on the European stakeholder level.

The frequency of the ENPOR newsletter has been enhanced by special issues and social media channels are ensuring digital engagement. Digital banners, videos, online presentations and infographics were produced that accompanied policy events such as the Pcompolicy Forum, Lunch Talks, Thematic Seminars (capacity building events) policy events and more, from September 2021 to November 2023.

ENPOR DIGITAL MATERIALS

2.1 Newsletter

The newsletter is based both on the project content and on an ongoing call for articles that is circulated every 6 months and posted continuously on the ENPOR website. The newsletter runs various columns. The main feature is dedicated to **ENPOR content**, news, and deliverables/reports. It is followed by a **feature article**, mainly focusing on themes related to ENPOR, such as the background or elaboration of ENPOR policies. The feature articles are followed by **community** and **partner news** and a **resources** section for scientific articles. **Special issues** are dedicated to single important ENPOR calls, such as the call to fill in questionnaires, calls to participate in events or announcements. The ENPOR newsletter subscriber list counts **266 subscribers**, the ENPOR Lunch Talks subscriber list had **131 subscribers**, **altogether 397 Subscribers** received regular news from ENPOR via mailing lists. The newsletter was furthermore distributed to **2000 recipients by ENEA**. ENPOR news were distributed via partner newsletters reaching **13,206 recipients**, thus ENPOR news reached altogether **13,598 recipients** exceeding the KPI of 5,000 recipients, reaching **272 % of the targeted value**.


Calls for Actions were posted in the slider to direct visitors to the relevant subpage. Important networking partners such as the Energy Poverty Advisory Hub, and later the Covenant of Mayors information is also posted. Blog posts deliver detailed context on interesting ENPOR results, such as the REACT Group interim findings. The ENPOR newsletter's concept also follows the idea of elaborating short news items in longer articles via the ENPOR website. The main

Events were announced on the website, to then be posted on social media. Event subpages contain relevant external information, such as links to registration, background information, links to resources, publications and recordings of the events (eg: ENPOR Lunch Talk – Energy Prices Skyrocket in Europe: Will Fit for 55 help the energy poor?)

The ENPOR website has a high level of online engagement with **42,232 views** and a total user engagement of 32,323. From February 2021 to November 2023, the website has experienced remarkable growth, with the number of users reaching an impressive 15,000. This increase over the period highlights the popularity of the platform and the effectiveness of the project. Looking at global engagement, the statistics show that the United States leads with 1,500 users. **Italy, Germany and Spain follow with 1000 users each.** The Netherlands, Greece and Mexico each contribute around 700 users, reflecting a consistent level of interest across different geographical locations. There are also users in China and Colombia with 200 users, demonstrating the global reach of the project. The diverse and widespread user base underlines the international attention given to energy poverty. Analyzing the sessions by default channel groups shows that the highest search is direct to the website with 13,000 sessions, indicating a strong presence in search rankings and relevant content. Direct entry via the website URL with 5,300 sessions shows a high level of user awareness of the project. The access to the website from external platforms, with 1,400 sessions, shows a successful content collaboration with external entities. **The online engagement with the events published on the ENPOR website shows a high level of interest. In total, there were 42,000 views on 25 events. In particular, the event "ENPOR - Energy Poor Households in the Private Rented Sector" has attracted a lot of attention with 13,500 views from 7,000 users. Secondly, the "Energy Poverty" event reached 5,000 views by 2,500 users. In total, ENPOR published a lot of news on its website with more than 400 posts in the period 2021-2023 to keep readers informed.** The article "Energy Poverty and the Role of Municipalities" on the Climate Alliance website in June 2021 received a lot of attention with more than 500 views.

The Energy Poverty Dashboard consists of 2 elements:

- Online maps to show the geography of energy poverty in the rented sector- and where available the PRS more specifically. The maps help visualise data at the national, regional and (where possible) sub-regional scale using datasets from EU-SILC, EU EPOV, and censuses and household budget surveys;
- An interactive map of policies related to energy efficiency in the PRS, including ENPOR ones. The map provides a visual record of relevant organisations operating at a variety of scales, with a range of geographical scopes. The interactive map allows local agencies providing on the ground support to help connect vulnerable households to relevant policies and provide a participatory platform for all stakeholders, in particular the national REACT Groups, to share experience of the policies and engage in local decision-making with regards to energy efficiency.

Rented Private Housing Energy Poverty Indicator (REPI) is a specialised multidimensional indicator to capture energy poverty in the PRS. REPI consists of a composite energy poverty indicator weighted by the proportional size of the PRS in a given area.

» STEPP INDICATORS

To complement the energy poverty indicators and to inform on the extent to which energy poverty in a country is localized in the PRS, a novel set of indicators reflecting the Share of Tenants in the Energy Poor Population (STEPP) according to the respective energy poverty indicator is calculated.

DATA QUALITY & ACCESS

In addition to the indicators, the dashboard displays information on the underlying sample size and statistical significance of differences between the overall population and the (private) rented sector. All displayed statistics are available for download.

3.3 The Split Incentive Tool

The ENPOR Split Incentive Quantification Tool – allocates the costs and benefits of energy efficiency interventions for landlords and tenants. The tool contributes to a deeper understanding about how to tackle energy efficiency in the private rented sector and aims to identify the share of the triggered benefits from the implementation of energy efficiency interventions between landlords and tenants in order to quantify the appropriate allocation of costs or subsidy rates for both sides, towards specific energy efficiency scenarios in several geographical/national contexts. 4 SOCIAL MEDIA

The social media and digital events material were always developed according to the content requirements of the individual events, news, highlights. Social Media campaigns were focusing on the dissemination of current results and launch events related to project results. Facebook and LinkedIn are mainly used to post ENPOR related information, while Twitter is a more interactive medium. In the last period of the project, posts focused on results, publications and Thematic Seminars bringing results close to the stakeholders. All ENPOR activities and project outcomes are distributed via social media, implementing the strategy of directing visitors to ENPOR materials and achievements via the website, online events or publications. Sister project events, stakeholder activities such as the EPAH and Covenant of Mayors related activities are also highlighted aiming to enhance a multiplicating effect. Partners reposted/retweeted ENPOR content to reach national stakeholders.

4.1 ENPOR's Twitter Channel


The best performing social media channel for ENPOR is Twitter. While it is also the most volatile and quick-paced, it provides the highest interaction rates for ENPOR, as its hashtag tool efficiently creates a community of profiles active in the same fields, while providing a tool for public awareness-raising on the same topic. In the case of energy poverty, this is a very powerful characteristic. With 516 tweets, the project channels **reached 85,185 Tweet impressions**, while the **501 followers** organically grew from 290 to 501 in the period of Month 18 to Month 42 (February 2022-November 2023) and **profile visits varying monthly between ca. 500 and 1200**. The highest activity was reached in the month of the ENPOR final event in the European Economic and Social Committee in Brussels, with over 600 impressions gathered. As a result **over 50 submissions to the Energy Poverty Dashboard** proves that our strategy works well in this setting. By looking into the statistics of Twitter, it becomes clear that high activity around events and project result launches provide higher target group reach than interactions, however this is due to the nature of the results of the first period of the project. In the second part of the project, when the recommendations of the REACT Groups become public, we expected higher engagement rates of partners and networking partners to reach higher policy impact as well.

4.2 ENPOR's Facebook Channel

The Facebook channel of the project was added to the originally planned two-channel strategy (Twitter and LinkedIn). The posts on Facebook engage the least, taking into account the adverse effect of public institution's engagement with the channel due to GDPR issues. Nevertheless, the project channel reached altogether interested stakeholders **2,680** times in the last 18 months, although with low interaction rate (as expected), triggering 295 direct page visits. Facebook Analytics show that spikes of activity on Facebook correspond with ENPOR events or publications. Towards the end of 2023, the density of activities increase, confirming the strategy of building awareness on ENPOR's work with frequent event activity.

The second most successful social media channel for ENPOR has proven to be LinkedIn. With experts being active in the fields related to energy poverty, this channel brings high interaction value. Looking into the statistics of visitors, the dynamics follow the dynamics of Twitter interactions, where events and result launches create most interest in time. It is worth to mention, that LinkedIn provided the most dynamic new follower metrics, with a rising value over the latest months. Currently the project **counts 447 followers**, all won organically.



5.1 Austrian Energy Agency: Energy saving measures– in 10 languages

New visual aid formats were created to support energy poor households in Austria. DIE UMWELTBERATUNG has been offering energy counselling for energy poor households in the target region of Vienna for many years. The Austrian Energy Agency initiated the co-operation with DIE UMWELTBERATUNG within the framework of the co-creation process in the Austrian ENPOR REACT group, to bring the greatest added value to advisory services for affected households. The stakeholder consultation and co-creation process in the REACT group led to revise already existing information materials on saving energy in private households and to create new advisory materials. These materials differ from previous offers by focusing on visual language, thus offering a clear advantage for this hard-to-reach target group by conveying information with as few words as possible using illustrations and pictograms. This communication method makes it easier to overcome language barriers or lack of background knowledge. The materials were translated into several languages to facilitate access for socially disadvantaged groups, especially with migration background. All versions were published on the ENPOR website printed in Austria, financed by the Ministry for Climate Action, and provided freely to energy and social advice services nationwide. They can order the factsheets for free in all the available languages. **Over 130,000 factsheets have been distributed this way in Austria already.**






Within ENPOR, our overarching aim was to further develop the existing approach of heating-related energy advice to increase heat savings and achieve better comfort level and to broaden the evidence base of what works. We partnered with Caritas Düsseldorf to further develop innovative approaches to be able to convey energy advice more effectively or to achieve savings by means of new tools and approaches. The Wuppertal Institute, Caritas Düsseldorf and Röthele Energie- und Bauberatung, analysed the existing StromSparCheck advisory process and practice and developed a new **media package to support the advice delivery**:

Ventilation information sheet: The ventilation sheet is one element of the developed media package. It shows the air circulation for four different ways of ventilation: shock ventilation, cross ventilation, tilt ventilation with door open and door closed. Using this illustration of 4 rooms, with blue and red arrows for fresh and stale air, and a related evaluation system with red stars where a maximum of 5 stars shows the optimum way of ventilation, the measure is meant to improve the information transfer and impacts of different ventilation methods by graphic display, which could accommodate not only target groups that have difficulties with the native language. The laminated sheet has been originally used for the training of the programme's energy advisors but is now handed-out to the visited energy-poor households as an easily understandable guide to ventilation in the heating season. Ventilation diary: Another element of the media package is a recording sheet with diagrams for temperatures and air humidity for various ventilation methods that is being handed out to the household together with a thermohydrometer. The household is asked to document measured temperature and relative humidity values from the thermohydrometer, before and after ventilation, using different forms of ventilation over a period of a week. Different colours in the diagrams, supported by embedded emojis, signal to the user where optimal and non-optimal combined values lie from a health perspective.

The aim of the diary is to strengthen the understanding for the issue, the impact of ventilation on indoor air




quality and interlinkage to personal well-being as well as promote the literacy with view to reading and understanding the displayed values on the thermohydrometers. **Download ventilation diary:** https://www.enpor.eu/wp-content/uploads/2023/02/Ventilation_diary.pdf

Close-to-action visual reminders: As a last part of the media package, the improvement comprises 1) transparent window stickers out of adhesive foils with ventilation instructions for the different seasons in terms of frequency and duration and 2) printed hangers for radiators with information on the thermostats settings and the corresponding temperature levels. Placing these reminders close to the action they advise on shall serve the tenants as a reminder and support the continuous implementation of contents of the energy advice. **Download** Window sticker and radiator hanger:

This report combines an in-depth review of academic and grey literature, an analysis of existing energy efficiency policies targeting the Private Rented Sector (PRS) and a primary scoping survey of stakeholders to generate a series of targeted policy recommendations to address the gender dimension in European energy efficiency policy. It should be noted that this report follows the definition of gender put forward by Robinson et al. (2023); gender is not a binary or discrete category, but intersects with and is constructed through "other forms of social difference, such as class, ethnicity, race, disability, sexuality and age", which shapes social relations in unequal ways (Robinson, Simcock and Petrova, 2023).

Protecting vulnerable citizens and tackling energy poverty have become specific policy priorities in the legislative package Clean Energy for All Europeans, and have been also recently strengthened with the Recommendation on Energy Poverty issued as part of the Renovation Wave package. In these documents, energy poverty is generally defined in terms of high-energy prices, low income and inefficient housing. Therefore, retrofit measures, funding mechanisms and targeted protection practices are often identified as a way to mitigate energy poverty. However, it is only when vulnerable citizens get their different needs, rights and experiences recognized, and have access to the energy decision-making process, that the energy transition is likely to leave no one behind. In this regard, energy citizenship represents a way not only to address energy poverty and vulnerability, but also to promote energy justice. However, its potential is still under-researched. This mapping exercise contributes to the recent emerging literature on energy citizenship by looking at the best practices offered by European projects.

This report analyses and assesses policies and measures that address energy poverty in the private rented sector (PRS) across Europe. We review intervention strategies aimed at reducing energy poverty in private rented properties, particularly scrutinising policies targeting vulnerable households in the sector. The overarching objective is to investigate the content, aim, and structure of PRS policies in this domain, noting key patterns in the coverage, distribution, and delivery of such initiatives. As a result, the review identifies some of the wider structural challenges in the type of support currently available to energy poor households. Policies have been identified on the basis of publicly available, non-confidential and nonpersonal information, collected between January 2021 and January 2023. Data was compiled by experts from the ENPOR consortium, as well as from submissions via the ENPOR Energy Poverty Dashboard (EPD) portal. Although 122 policies appear on the EPD (as of 31st March 2023), 114 are included in this analysis, as a result of insufficiently available information for the remaining measures. The resulting dataset is a diverse set of measures operating at different geographic and governance scales, and with highly variegated programmatic objectives.

CONCLUSION

ENPOR news were distributed via ENPOR newsletters and partner newsletters reaching 13,598 recipients exceeding the KPI of 5,000 recipients, reaching 272 % of the target value. The consortium organised and participated in over 150 events, and contributed to scientific and policy discussions online and offline. ENPOR digital materials reached ca. 20,000 people via partners websites, and reached almost 100.000 impressions on ENPOR social media. The ENPOR website engaged stakeholders over 44,000 times and printed online materials are being used beyond the project with the Austrian energy saving tipps being printed and distributed to 200.000 citizens and advisors. ENPOR engaged a variety of stakeholders and collaborated actively with all sister projects and organised several events together with the Energy Poverty Advisory Hub and the Covenant of Mayors, submitted recommendations on national and local level to policy makers and impacted national policy measures such as the Greek or Estonian Renovation Grant, the extended heating advice for Stromsparcheck or the Energiebox, even contributed to the creation of a new training programme on Social Energy Advice in Austria. We are confident, that despite the difficulties of the COVID pandemic, ENPOR made a considerable impact.
